RULES AND CONDITIONS OF SUPPLY

BF SERVIZI will supply water and compressed air services within the limits of the systems at its disposal, subject to the following terms and conditions.

These services must be requested by means of this Form, which must be sent to BF SERVIZI, duly filled in and signed, by the deadline specified on the Form. The request is binding on the Exhibitor for all purposes and effects.

BF SERVIZI will not be required to supply the requested services if the Form is submitted after the deadline. The guarantees and risks conferred to BF SERVIZI by utilities will be transferred to the Exhibitor for such services.

WATER

BF SERVIZI will make the connection to the water mains after conducting a feasibility check.

All costs for installing the distribution network and for connecting to the stand will be charged to the Exhibitor.

BolognaFiere S.p.A. will lay the water feed and drainage pipes around the perimeter of the stand.

The Exhibitor is strictly prohibited from making the connection to the BolognaFiere S.p.A. water mains by means of its own personnel, and undertakes to use only authorised personnel for such purpose. Otherwise, it will assume all liability for any damage caused to persons or property.

The service is provided only in exhibition areas equipped with general utilities.

The Exhibitor is prohibited from discharging waste water into the secondary tunnels of the Halls without using specific discharge pipes to be connected at the drains.

Under all circumstances, it is prohibited to dispose of water that corrodes metals and cement, solidifying substances, and foul-smelling water.

The Exhibitor is required to conform to the acceptable limits for waste water provided by law.

COMPRESSED AIR

Compressed air will be delivered to the stand at a point determined by BolognaFiere S.p.A. with a screw-type gas coupling female thread ½" diam. and delivery pressure from 7 to 8 bar.

BF SERVIZI reserves the right to supply the service with individual compressors to be placed in the stands.

The Exhibitor is required to use first-quality materials and equipment for the part of the system that it is responsible for (from the BolognaFiere S.p.A. delivery point to the Exhibitor's points of use); all systems must be designed and built to industry standards and suitable for the specified pressure.

Connections at delivery outlets may be made only by workers of the specialised company authorised by BF SERVIZI.

The Exhibitor is strictly prohibited from making the connection to the BF SERVIZI delivery point by means of its own personnel, and undertakes to use only authorised personnel for such purpose. Otherwise, it will assume all liability for any damage caused to persons or property.

BF SERVIZI will not be liable for any damage or defects attributable to the quality or quantity of air delivered.
